| Event name | "Zonal Association" Continental Tour-Zonal Event |
| Application forms | Duly completed BV-A2 and Zonal Tour Homologation forms |
| Application deadline | Min. 35 days before the event |
| Competition Dates | To be coordinated and approved by the CEV |
| Number of events | Five (5) events per gender per Zonal Association - Max. 1 event per gender per National Federation. Zonal Associations retain the option to organise additional events to the above-defined number in case they organise a CEV Masters in their territory (event additional to those already confirmed in the CEV calendar as of 29/03/2018) |
| EVENT CONDITIONS | |
| Venue Facilities | Set by the organising Zonal Association and in line with FIVB Official Beach Volleyball Rules |
| Duration | Min. 2 days Main Draw |
| Participating teams | Min. 12 team Main Draw with a min. participation of 3 National Federations. Participating NFs must be affiliated to the respective Zonal Association, apart from one Wild Card that may be allocated by CEV to a non-member NFs. |
| Prize Money | Minimum of 1'500.- EUR up to maximum of 4'000.- EUR per gender per event |
| Registration Procedure / Regulations & Forms | Mandatory usage of CEV/FIVB online registration system and of CEV BV-01 Players Commitment and Health Certificate form. CEV License fee of 20-EUR per athlete (once per season). Registration Deadline: - 15 days from the first Preliminary Inquiry Confirmed Teams lists: - 10 days from the first Preliminary Inquiry Participation fee: According to the Competition Regulations of the respective Association Competition Regulations in regard of quotas, position of Host Country teams, competition format are according to the respective Zonal Association Competition Regulations. For any issues not covered within these regulations the CEV regulations shall apply. |
| Court Equipment | In line with FIVB Official Beach Volleyball Rules, ball homologated by FIVB |
| ORGANISERS OBLIGATIONS | |
| Zonal Association | Enforce the FIVB Official Beach Volleyball Rules. Assign in the beginning of the season of a contact person to collaborate for all competition related issues with CEV. Provide CEV with the Zonal Association Competition Regulations document prior to the 1 st CEV-Zonal tour event of the season. Appoint one Technical Supervisor per event, with good knowledge of the CEV and Zonal Association Competition Regulations who will coordinate the competition and report to the Zonal Association/CEV after the event. This Supervisor should either feature in the CEV/FIVB Technical Supervisors list or be approved by CEV based on previous experience in Beach Volleyball events. |
| National Federation/ Organiser | Submit the assigned to the event referees and Referee Manager through BV-LR form to CEV for approval, with a minimum of 1 International referee per court. Assign either a CEV/FIVB Referee Delegate or an FIVB International Beach Volleyball Referee to act as the event's Referee Manager. CEV may also approve for the task a National referee with prior experience as Referee Manager in International BV events. Assign a VIS manager for the competition software with a good understanding of Beach Volleyball competitions. Forward a preview and a daily report at the end of each competition day to the CEV Communication Department, accompanied with photos. |
| Post Event Report | Send a post event report including results, rankings, photos and sample of all printed materials the latest 7 days after the event. |

| Broadcasting rights | National TV rights, all other broadcasting rights remain with the CEV |
| FIVB/CEV Ranking Points | Yes, in case all organising terms and conditions are fulfilled |
| Comp. Software (VIS) | Yes, mandatory usage for the allocation of FIVB/CEV ranking points |
| MARKETING & PROMOTION | |
| Television production | In case of TV Production this must follow the guidelines of the CEV and the TV signal should be available and free of charge to CEV/TV agency |
| Promotional Productions | Use of the CEV marks in all publications and promotional activities following CEV approval |
| Panels, Flags and Backdrops | Three CEV/CEV Campaign panels in each court in pre-determined positions, plus one CEV flag in a predominant position in the venue/tribune and minimum 1 event title panel per court Submit image and identity materials to be produced for CEV approval, according to CEV Marketing Regulations and Guidelines. |
